SUBJECT: Minutes of Board of Governers (BOG) on July 7th, 2015

1. The National Guard Association of Nebraska (NGA-NE) conducted its monthly BOG meeting July 7, 2015 at Brewsky's Haymarket, Lincoln NE.

2. In addition to the attendees at the Executive Committee meeting, Maj Ginny Witulski was also present.

3. Meeting called to order at 1834.

4. President's Report:

2015 National Conference

- Review EXEC mtg discussion
- NGB-funded nominees need to find out who Army selected; Air has individual named
- In past, NGA-NE funded 2X Army and 1X Air and suite (host of suite stayed in room but travel was not paid)
 - BOG allowed CGO to stay in suite to run it
 - Discussion: Should we do the same as last year (spent ~\$3800) or scale back and have one person chosen (out of 3 named) to run suite
 - Tabled vote until 4 August meeting; agreed to figure out budget first, then decide on funding for the conference
 - Come to meeting with nominations; names needed NLT 8 August
- More functional/informational schedule proposed for suite, conference attendance, etc.
- Delegate and Resolution Selections Lt Doug Carlson created handout to provide folks prior to leaving to ensure all are informed; we'll have 16 delegates

Suggestion to review numbers again, specifically expenses / profit from golf tourney

7. Legislative Report: Lt Kramer for Maj Bettey

- 13 Sep date to submit proposal for governor's sponsor; if have issues to bring forward for TAG to champion, need to propose within next 2 weeks in order to have finalized by mid-August
- Fed side / Congressionals Gen Bohac and Lt Kramer meeting delegation next week; social at General Kadavy's home; 3X socials in next week
- Governor's Agenda committed to tax reform relief on military side; dependent on consensus to move forward
- No issues proposed by BOG at this time
 - Lt Kramer encouraged coming up with ideas; educating members, building relationships
