The Nebraska Military Retiree Council met at 9:00 am, October 9, 2019. The meeting was called to order by President Bill Nelson.

Secretary's Report: The minutes of the previous meeting were e-mailed to members. We have 552 members.

Treasurer's Report: Current balance in checking is \$9716.04. Outstanding deposits of \$75. A motion to approve the Treasurer's report was made and seconded; the motion passed.

OLD BUSINESS:

The NNG Prescription Drug Program located in Lincoln no longer exists.

Annual Retiree Briefing which was to be held October 19th has been postponed due to unforeseen. circumstances.

NEW BUSINESS:

The 2020 Election Ballot was reviewed for publication and approved. The positions for nomination or reelection are Vice President, Treasurer, one Army and one Air Members-At-Large. The ballot will be included with the minutes for return by December 15th.

The 2019 Founders Award was reviewed for publication and approved. The nomination form will be included with the minutes for return by December 15th.

The options for next year's Spring Social in May will be researched by John Bailey. The NNG Museum in Seward is being considered again.

The Tailgate on October 5th at the Spirit of 76 was a huge success. According to LTC Henrickson over 400 attended with many retirees.

Welcome SFC Amber Gralheer as the ARNG Retirement NCO. She will be checking into an agenda and location for a Retiree Brief next spring. An option will be Memorial Hall at Cp Ashland if available by next year (due to flood). She has a goal to get to out-state locations quarterly for briefing 18-20 year members and assist with retirement. Discussion was held on lack of support for ANG retirees. She will try to find a way to work with ANG to provide newly retired members a comp year. The ARNG members wishing to provide information will continue to be given an NMRC complimentary year membership.

Discussed an inquiry from Garth Scism regarding TRICARE health coverage for a widow of a guardsman (not retired) who passed. Looking for support of an initiative at the national level to expand survivor benefits to include a form of TRICARE. The NMRC will support any legislation that may come forward from NGAUS/EANGUS.

A motion was made by Gary Hansel to change the Constitution Article II to read:

SECTION 3: The dues of the Council will be \$5.00 per year (this includes dual spouse membership), payable in advance for one year (1 January - 31 December). Members attaining the age of 85 will be eligible for membership in good standing without the payment of dues. Members will not be in good standing, except those attaining age 85, during any period for which dues have not been paid.

Motion Seconded by Merlyn Schuster. All NMRC members should forward comments or responses to the NMRC. Voting on Constitution change will take place during the January 8, 2020 meeting.

No further business was discussed. Meeting adjourned at 0945, October 9, 2019.
