### President's Report: COL Golden

- Insurance Meeting: vote coming up about changing insurance companies
- Leadership Dinner: coming in November
- Brief today by exception only

### Secretary's Report: 1Lt Frengs

- August minutes were submitted by Lt Henrickson

- Motion: moved and seconded, **unanimously approved**

### **Treasurer's Report: Lt Rowley**

- Balance: \$77992, with \$34k in the CD
  - CD Rollover: we are in our 10 day window, \$140 earned in last 3 years
  - Locked in for 10 months, cannot take it out without penalty
    - Possibly use those funds for future CGO Event or comp a CGO for NGAUS
    - CDs do not historically do well with keeping up with inflation
    - Do we take the money out and reinvest in another mechanism?
  - Why are we keeping such a big portion of our assets in low yield CD, rainy day funds?
    - How much should we keep in our liquid assets?
  - We need to do some yearly analysis on our budget (priority for 2021?)
  - Suggestion: pull the money out, let it sit in the account, present COAs at February Business Meeting
  - Motion: on above topic, Curto seconded, passed unanimously

### **Executive Director: LTC Henrickson**

- Insurance Trust Meeting (LTC Henrickson attended): 25-26 SEP @ Portsmouth, NH
  - Insurance Carrier: do we have better options?
  - Better Alternative: in addition to SGLI, SSLI (AFPA/New York Life)
  - New Provider: MBA would like to get into the business (partner with MetLife)
    - Rates would stay the same for 5 years
    - Enhancements include will preparation
  - Trust Voted: by 31 Oct we would have a draft contract
    - States in the trust would review in November BOG Meeting
    - 10 Dec: trust votes by Zoom meeting, by majority
- 2019 IRS Update: fighting \$760 charge, has been waived
  - FY 2020 ends 30 JUN, taxes were submitted 24 Sept
