Short refresher and references sent by e-mail to members.

Unfortunately, we were unable to hold Retiree Briefings in 2019 or 2020 but, looking forward to one in 2021.

Under #2, the website for 2021 legislation being proposed can be found on the "tracker" link.

Do you or others know where your DD 214 (Active Duty) or NGB 22 (National Guard) discharge documents are?

1. **LB 153 passed in August 2020.** Change provisions relating to the taxation of military benefits. It is designed to exempt 50% of military retired pay from Nebraska income tax. https://www.nebraskalegislature.gov/FloorDocs/106/PDF/Final/LB153.pdf

Be sure to have your discharge documents. With LB153 there will likely be a form and documentation requirements for excluding military retirement benefits from Nebraska Taxable Income. The previous law for excluding military retirement benefits required. Be prepared with official documentation, such as a DD Form 214, Discharge Papers and Separation Documents; DD Form 215, Correction to DD Form 214; Certificate of Release or Discharge from Active Duty; DD Form 363, Certificate of Retirement; NGB Form 22, National Guard Report of Separation and Record of Service; or official retirement orders. If both spouses retired from the uniformed service each will need to provide.

5. The National Parks and Federal Recreational Lands Pass: Announced nationally and locally.

Entrance fees for the National Park Service and U.S. Fish and Wildlife Serve and standard amenity recreation fees will be waived for veterans and Gold Star Families. For purposes of this program, a veteran is identified as an individual who has service in the United Stated Armed Force, including the National Guard and Reserves and is able to present the following forms of identification: DOD ID Card, Veteran Health ID Card, government issued Veteran ID card or a state-issued U.S. driver's license or identification card confirmed an individual's status as a veteran. https://www.nps.gov/planyourvisit/passes.htm

6. Applying for Retirement:

ARNG: It is important to "Gray Area" retirees that filing for your Age 60 retirement (or earlier due to deployments) does not come automatically. Retirement applications should be submitted around 9 months but not less than 90 days prior to your 60th birthday to ensure all is processed correctly. They also provide a benefit brief on such areas as TRICARE choices, Space A Travel, Funeral Honors, dental options and Survivor Benefits Plan (SBP). Contact the NG Retirement NCO, 402-309-8162

2020 ANG ID Services: The FSS ID Card website to make appointments for Retirees.

For appointment, unless medically necessary, dependents should NOT accompany the retiree. New spouses or Medicare newly eligible are the exceptions as they must be with the sponsor.

Dependent ID cards are temporarily suspended UNLESS it is an emergency and directly affects usage of benefits.

2020 ARNG ID Services: To set up an appointment contact (402) 309-8191

At this time, we will not be doing ID cards unless it is to get a brand new one or expiring within 30 days, we will NOT be doing them because of a change of status as of now. **TRICARE is aware so if the ID card is expired the benefits will still be continued as long as eligible for them.

If you are using on-line services for retired pay there is a two-factor authentication. The website you can view or print your LES, W-4's, 1099's (for taxes) and change personal information.

Keeping your beneficiary information and your SBP beneficiary current with DFAS will ensure that your survivors promptly receive their benefits.

9. TRICARE coverage: All programs you must now enroll in. They are no longer automatic

Tricare Select - age 60 and over and not Medicare eligible - premium enrollment fee begins 1 Jan 2021

TRICARE Select Group A (does not include TRICARE for Life) must pay monthly enrollment fees in order to maintain their TRICARE health coverage. Group A (retirees & family members) will need to pay enrollment fees annually of \$150 for an individual and \$300 for family coverage.

If you are covered under Medicare and TRICARE for Life (TFL) this will not affect you. **BUT** if you have a spouse or family member not under TFL and utilizing TRICARE they will pay an enrollment fee. https://www.tricare.mil/Plans/Enroll/OpenSeason. Example: You are 68 on Medicare and TFL and your spouse is 64 not on Medicare. Your spouse would be on TRICARE Select with an enrollment fee until covered under Medicare and then TFL. Cost is waived for survivor, a medically retired retiree or family member.

<u>First Time Eligible Enrollment:</u> Turning age 60 and filing for retirement or retiring from active duty, you are responsible for signing up for the TRICARE medical benefits.

It is not automatic with your ID card. https://www.tricare.mil/LifeEvents/Retiring/GuardReserve

- a. You have 90 days from the Qualifying Life Event (QLE) to enroll in TRICARE and DEERS (getting your ID card).
- b. If you wait and do not file for your age 60 retirement and wait until you are 62 your QLE is still when you turned 60. This means you will have to wait until an Open Season, another QLE or "if space available at military facility" to have TRICARE coverage.
- c. If you have not enrolled and use your ID card for TRICARE at a civilian facility, because it has a medical "benefits number" on the back, it will still be your responsibility for the bill.
 - d. Enrollment is on line, call or mail in a form.

<u>Tricare Reserve Select (TRS)</u> – current serving NG or reserve - has premium

<u>Tricare Retired Reserves (TRR)</u> – Gray Area – prior to age 60 – has premium. Coverage for those under age 60. A premium-based health plan that provides medical coverage for retired National Guard and Reserve members under age 60. For more information: https://www.tricare.mil/Plans/HealthPlans/TRR

<u>Tricare Prime</u> – generally, must live near a Military Treatment Facility (MTF) - has premium

TRICARE and Prescription Options for Retiree's:

Requirements: a. Retired National Guard and Reserve Members (Age 60 or above and receiving retired pay), families, survivors, widows/widowers and certain former spouses.

- b. Retired AGR's continue coverage.
- c. Up-to-date ID card. Input to the DEERS ID system flows into the TRICARE system.

Options for Prescriptions: TRICARE approved pharmacy, TRICARE mail/home delivery service, or Military Installations such as

OFFUTT or Warren AFB, WY.

Any veteran that uses **VA Health Care** and presents at a civilian Emergency Room needs to ensure the Department of VA is notified within 72 hours. Veterans need to let their family members know about this. Effective 8 June 2020, the Office of Community Care requests that all community hospitals and/or providers notify the VA of a Veteran who self-presents to an emergency department within 72 hours of the start of the episode of care.

10. **Federal Dental and Vision (FEDVIP):** Just retired or have a life event you have eligibility to enroll in FEDVIP outside the annual open season (xx Nov - xx Dec each year).

If you're newly retired from the military and will receive pay, you have 60 days from the date you became eligible to enroll in a FEDVIP dental and/or vision plan. To review or enroll you much first check your eligibility and create a My BENEFEDS account. Then, select "Enroll" in dental or vision coverage from your account dashboard.
