SFC Olsen discussed trying to hold a Spring RAD event. Tentative date is April 11, 2026, and the location is still to be determined. It will most likely to be '76 Armory but she needs to see if any units will be drilling there that weekend. SFC Olsen is also trying to get funding for lunches; if they get funding, there will be a requirement to RSVP for the event.

CMSgt Scott Tontegode discussed the Government shutdown is creating some issues for the Guard; pay issues and who can attend drill. On the ANG side OPS Group and Maintenance Group will be going away by April 1, 2026. There will be a reorganization of the command structure for those two groups. The 170th at Offutt AFB is continuing to grow and the Air Guard had a record 151 new accessions for FY 25.

We're exploring the possibility of having retirees volunteer at the JFHQ front desk. Volunteers would serve as greeters, assist visitors with directions, and help answer general questions. At this stage, we're gauging interest and working through the details.

The general plan is for retirees to volunteer when they're available and willing. Volunteers would receive training and could sign up for specific day and time slots either through a website or by coordinating directly with a NENG volunteer coordinator. More information will follow.
