

NMRC MINUTES

January 9, 2020

The Nebraska Military Retiree Council met at 9:00 am, January 8, 2020. The meeting was called to order by President Bill Nelson.

Secretary's Report: The minutes of the previous meeting were mailed or e-mailed to members.

Membership: As of December 31, 2019, the NMRC had 581 members. The Council would like to encourage all members to invite others to join. Information sharing has proven beneficial to many for events, rights, benefits and retirement.

Treasurer's Report: Current balance in checking is \$10,773.78. A motion to approve the Treasurer's report was made and seconded; the motion passed.

OLD BUSINESS:

The 2020 Election ballots were counted and the results were as follows: Vice President re-elected: Dick Burch Treasurer re-elected: Al Riggins Members-at Large re-elected: Randy Frazier (Army) and Gary Hansel (Air)

The 2020 Founders Award nominations were reviewed. The approved recipients will be announced after they have been notified. Presentations will be held at the Spring Social.

Save the Date: John Bailey reviewed dates for the Spring Social to be held at the NNG Museum in Seward. Plans are for the event to take place on Saturday, May 23rd. Details will be sent out in April.

Constitution changes were discussed. A motion was made to approve the change presented at the October 2019 meeting. The motion was seconded with the vote unanimous to approve Article II Section 3 to read:Members attaining the age of 85 will be eligible for membership in good standing without the payment of dues. Members will not be in good standing, except those attaining age 85, during any period for which dues have not been paid.

A motion was made to update the Constitution Article VI for the nomination of officers to reflect the January 2017 Article V change from monthly to quarterly meetings. The motion was seconded with the vote unanimous to approve Article VI Section 1 to read: ...Officers will be nominated at the regular October meeting; elections will be held during the 4th quarter of year; elected Officers will assume their duties at the following 1st quarter regular meeting.

A motion was made to approve \$60 for Wreaths Across America to be placed on December 14th at Wyuka Soldiers Circle. The motion was seconded and approved.

NEW BUSINESS:

Bill Nelson discussed that LB 153 (military retirement tax relief) will be forwarded to the Nebraska Legislature for debate in the next couple weeks. Notification of the date and time will be sent out when announced. Support for this bill with letters and attendance at the debate is highly encouraged.

Bill Nelson discussed the options being reviewed for the Annual Retiree Brief. SFC Amber Gralheer as the ARNG Retirement NCO is checking into an agenda and location for a Retiree Brief during the summer or fall. An option will be Memorial Hall at Cp Ashland when available due to the flood repairs.

Dick Burch announced the next Veterans Career Fair will be held in April.

No further business was discussed. Meeting adjourned at 0930, January 8, 2020.
